■ Qualification

1. Applicant Eligibility

- **Citizenship:** Be a citizen of the scholarship program target countries.
- **Level of Education:** Have a completed Bachelor's degree or the equivalent.
- **Government or Institution Nomination:** Be officially nominated or endorsed by his/her government or institution.
- **English Proficiency:** Have a sufficient command of both spoken & written English to take classes conducted entirely in English.
- **Health:** Be in good health, both mentally and physically, to stay in Korea for their program period.
- **Age:** Be 45 years old or younger at the time of the application.

May 11 – May 15, 2026

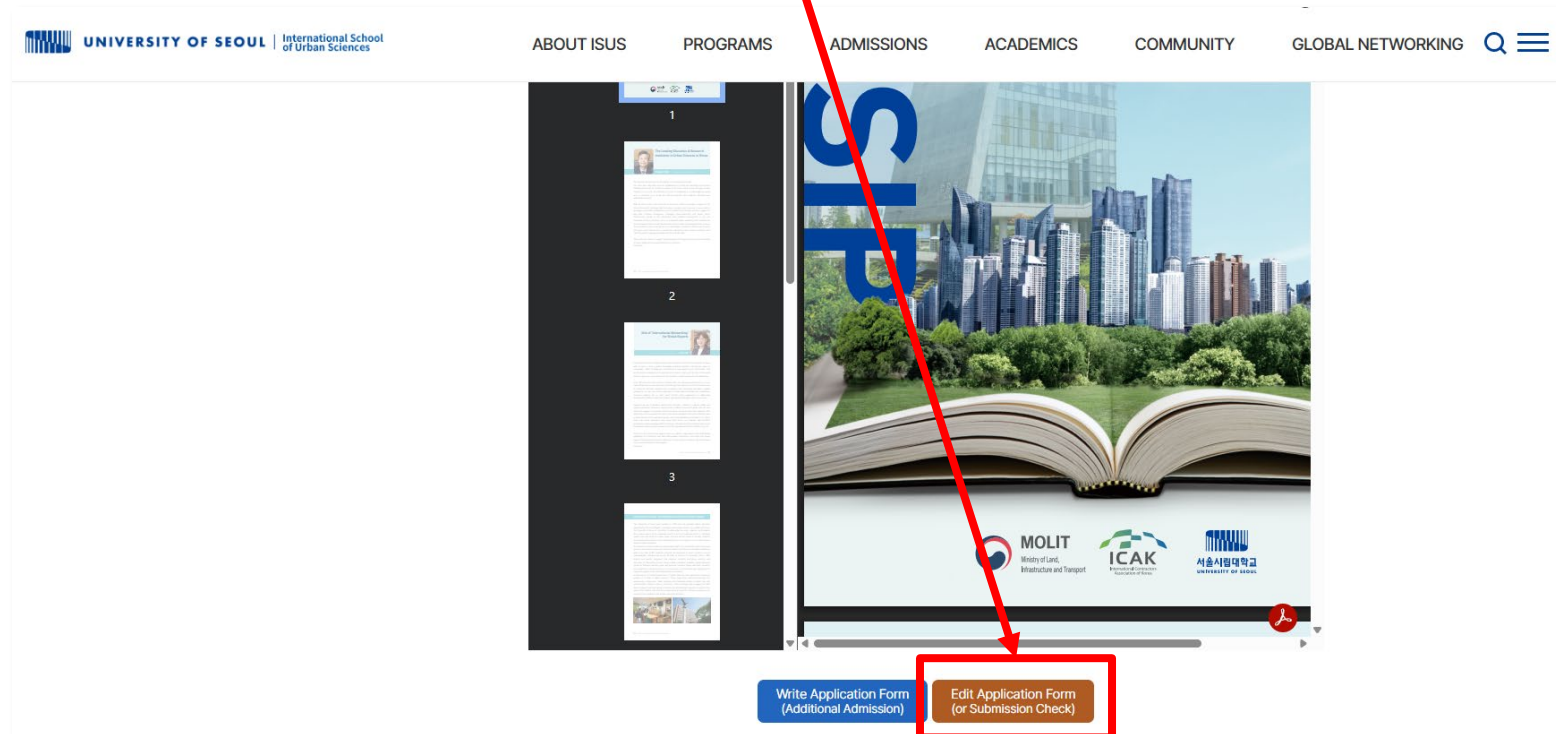
- If you are accepted to the Zoom interview, **candidates must appear at the Zoom test meeting.** (Zoom test date and time will be informed via email.)


